The authorized employees of Citadele banka AS will perform the processing of your personal data in the frame of video surveillance for the mentioned purposes and on the mentioned grounds.

WHOM DO WE TRANSFER YOUR PERSONAL DATA?

- in cases specified in regulatory enactments, for fulfilment of requests of competent public institutions to a court, investigative bodies, prosecutor's office, intelligence operation subjects and other persons specified in regulatory enactments who have the right to request and receive such information;
- in cases specified in regulatory enactments, for the protection of our legitimate interests to public institutions, law enforcement authorities, investigative bodies, courts.
- to employees of Citadele banka AS whose work duties include ensuring video surveillance.

HOW LONG DO WE STORE YOUR PERSONAL DATA?

We store video recording with your personal data in accordance with the terms of storage specified below.

At the end of the period of storage of video recordings, we ensure deletion of your personal data, unless the storage of a video recording is necessary for investigation purposes.

WHAT ARE YOUR RIGHTS WITH REGARD TO THE PROCESSING OF YOUR PERSONAL DATA IN THE FRAME OF VIDEO SURVEILLANCE?

WHAT TO DO IF YOU THINK YOUR PRIVACY IS INFRINGED?

In the event of a violation of your privacy, you have the right to file a complaint with Citadele banka AS, the Data State Inspectorate, or to take a legal action to protect your legal interests.
