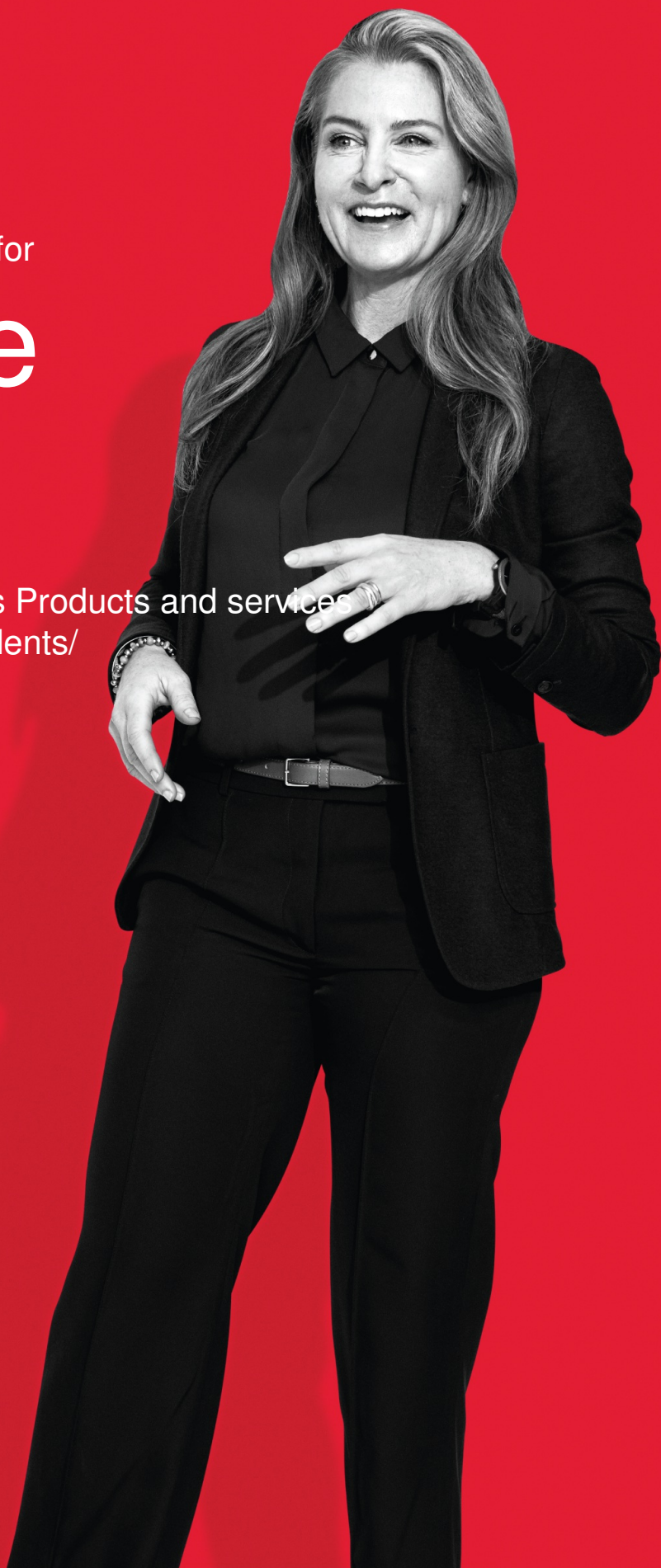

1. Cash operations¹

Service	Fee
1.1. Cash deposit to account in Citadele bank per each deposit (incl. payment in EUR up to EUR 15 000 to State Treasury without using current account) ²	0.5% of amount (min. 10 EUR)
1.2. Cash withdrawal from account in Citadele bank and currency exchange	0.7% of amount (min. 10 EUR)
1.3. Additional commission for coin processing for EUR coins	10% of amount (min. 20 EUR)
1.4. Cash withdrawal over the branch limit	3% of deal amount (min. 25 EUR)
