1. Cash operations¹

1.1. Cash deposit to account in the branch of Citadele bank (incl. payment in EUR up to EUR 15 000 to State Treasury without using current account) ²	1% of amount (min. 30 EUR)
1.2. Cash withdrawal from account in the branch of Citadele bank	3% of amount (min. 30 EUR)
1.3. Additional commission for EUR coin processing	10% of amount (min. 40 EUR)

2. Escrow account

2.1. Processing of escrow account agreement or amendments	Individually, information in the bank

3. Authorization Devices

Service	Fee
3.1. Issuing of DIGIPASS GO3	12 EUR
3.2. Replacement of DIGIPASS GO3 due to technical reasons (within 2 years from the moment of connection)	Free of charge

4. Additional services

Service	Fee
4.1. Processing of each received document for acceptance, inspection and execution of sworn judicial executor's orders and State Revenue Service's collection orders ⁴	15 EUR
4.2. Usage of courier deliveries and postal services upon customer's request for document and other values sending	25 EUR + actual expenses (VAT included)
