### Who will process your personal data?

### What types of personal data will we be processing?

Your—the participant's—name, surname, phone number and email address.

### Why are we processing your personal data, and what is the justification?

### To whom will we give your personal data?

For the reasons stated above, your personal data will be processed by authorised Citadele employees.

### How long will we keep your personal data?

The personal data of Event participants will be stored until 17.11.2024. or until such time as disputes are resolved, if such a dispute arises.

### What are your rights regarding the processing of your personal data?

All information will be passed on to the relevant employee who will answer your query.

You have the right to revoke your agreement to processing your personal data both using the methods stated below, and in person by calling +371 29997770. When you revoke our right to process your personal data, please bear in mind that you will no longer be able to participate, and this revocation does not affect the legitimacy of your personal data processing before your revocation.

In accordance with the law, Citadele gives you the right to access your personal data, edit or delete it, limit its use, forbid its processing or transfer it by submitting a written request.

You can submit your request:

- in person at Citadele's Customer Service Centres by showing a form of ID (passport or ID card), where you will be given all necessary information regarding submitting a request, including answers to any uncertainties you have;
- by email, signing your request with a secure digital signature and emailing it to [info@citadele.lv](mailto:info@citadele.lv);
- through the online bank or mobile app, if you are our customer and use these tools for everyday banking.

**What should I do if I believe my privacy has been breached?**

If your privacy has been breached, you have the right to protect your interests protected by law by submitting a complaint to Citadele, the Data State Inspectorate or in court.
